Student entrance and exit for students Years 7-11

Entrance to site from 8:15am	<p>Both the Beechcroft Road and the Glenburnie Road entrance will be open for students.</p> <p>This is in response to student and parent feedback.</p> <p>We are confident this will help all students be punctual to school</p> <p>As a reminder, both gates will close promptly at 8:38am; any student arriving after this time will be marked late and set a detention.</p>
Exit from site at 3:10pm	<p>Students will be able to use either the Beechcroft Road or the Glenburnie Road exit when they exit the site at 3:10pm.</p> <p>Both of these will be open, supporting calm and prompt student dismissal home.</p>

Students in Year 12 and 13 will continue to use the entrance and exit to the **Sixth Form Centre on Beechcroft Road**.

Planners

A significant change for the Spring Term is the introduction of Student Planners for all students in Years 8–13, who will now join Year 7 in using these as part of their daily routine at EBA.

This initiative is designed to support students in becoming more independent, organised, and responsible for their learning. It will also provide a clearer method of communication between school and home, allowing parents and carers to monitor:

- Messages from teachers

Students are expected to bring their planner to school every day and have it on their desk during every lesson.

We kindly request that parents and carers check planners regularly, and sign them at the end of each week in the space provided.

Arrangements for eating and drinking

We have increasing concerns regarding litter and food-related waste on the playground. This issue negatively affects the environment, poses health risks, and places an unfair burden on our site team.

From Tuesday 6th January, students will no longer be permitted to consume food or drink in the playground, including items brought from home. To ensure sufficient indoor space, additional tables have been installed in the main hall where students may eat with their friends at break and lunch. Students must clear their tables once finished before going outside. Only bottled water will be permitted in outdoor areas.

Although this is a significant change, we are confident students will respond positively. This measure will help maintain a cleaner, more professional environment. Students who fail to follow the new expectations will receive a sanction, and any food will be confiscated.

Attendance

Attendance across the academy improved during the Autumn Term. Our attendance figure of **93.3%** was above the national average of **92.1%**, and higher than that recorded for 'similar schools' in government analysis.

Despite this improvement, nearly 7% of students absent on any given day is still too high and will impact achievement. We have high aspirations for further improvement to support students in meeting their academic goals.

Our expectation remains: Every student, every day.

To recognise excellence in attendance, 108 students from Years 7–13 who achieved 100% attendance last term were invited to a 'Pizza Party' celebration on Thursday 18th December 2025. We are extremely proud of their commitment and hope this encourages others to strive for the same.

Any student who arrives at school after 9:00am	1hr detention at the of the day. (Where lateness is critical or persistent, this sanction will be escalated)

Mobile Phones

In 2025–26, we introduced changes to our mobile phone policy due to well-evidenced concerns regarding their impact on students' wellbeing, safety, and learning. This policy remains in place:

- Mobile phones must be switched off at the gate and remain off and stored in bags until students leave the site.
- *Hear it or see it, we take it:* any visible or audible phone will be confiscated and held until a parent meets with a Head of Year or a member of SLT. Phones will not be returned to students directly.
- The academy will not investigate mobile phone issues occurring on site (e.g., loss or theft).
- Parents and carers are expected to carry out regular checks to ensure phones are used safely and appropriately.

Online safety

We strongly encourage all parents and carers to actively monitor their child's online activity, including social media use, messaging apps, and general internet access - particularly outside school hours. Parents should ensure they can access all devices and have the necessary passwords and PINs.

Frequent checks are essential for safeguarding young people from harmful content or behaviour. Any online concerns should be reported directly to the provider via their reporting system, and you may also report concerns to the police. We will continue to educate students about safe, responsible use of technology and the risks associated with online behaviour.

All staff at EBA remain committed to working in partnership with students and families to support an ambitious, successful future for every child. Our dedicated teachers and support staff are ready to help all students achieve their full academic potential.
